Case Management Competencies

- Providing clinical rationales to explain prioritisation of goals, that enable cases to progress sequentially.
- Leadership across MDT / multi-agency cases, often where there are complex dynamics, making sure different agencies are working collaboratively.
- Management of direct and agency care teams, ensuring that the client is getting the greatest benefit from the intervention.
- Monitoring and working within budgets to offer maximum output with available resources and explaining rationales for further funding requests, with short and long-term explanations.
- Mentoring and supervision to less experienced case managers, or those experiencing new issues on cases, to problem solve and progress cases, and safeguard our clients.
